SCOPE OF ENDORSEMENT - CERTIFICATE OF PARTICIPATION IN HIRA LEVEL I

This certificate of participation confirms that the centre/person mentioned on the front of this certificate participated in the educational DAN Hazard Identification and Risk Assessment program and declared that the following requirements are met:

| TRAINING

- Staff trained in First Aid, BLS and oxygen administration

| EQUIPMENT

- First-aid kits and oxygen units readily available at dive site or pool

| INSURANCE

- Business general and/or professional liability insurance is required

| STANDARD OPERATING PROCEDURES (created and used)

- Pre-dive safety briefings (for pool and dive site)
- Boat safety briefings
- Post-dive briefings and post-dive head count using physical checklist

Should any of the listed prerequisites, for whatever reason, no longer be respected, this certificate should no longer be displayed and DAN should be informed immediately.
